Dear Mr. Cahayon:

We are pleased to inform you that **Purchase Request Number 23-5532** for the **Job Order (Labor & Materials)** with a contract price of **One Million Three Hundred Eighty Eight Thousand Eight Hundred Pesos Only (Php1,388,800.00)** has been awarded to you being the single responsive bid under **Negotiated Procurement, Section 53.1 Two Failed Bidding of RA 9184.**

Pursuant to **Section 39 and 62** of the revised **IRR of RA 9184** that "You shall post the required Performance Security, Ten (10) Calendar Days from the receipt of this Notice."

In addition, the winning bidder is required to submit all the required documents prior to the submission of Performance Security:

- 1.) Philgep's Certificate
- 2.) DTI/SEC
- 3.) Mayor's Permit
- 4.) Tax Clearance
- 5.) Audited Financial Statement
- 6.) Net Financial Contracting Capacity (NFCC)
- 7.) Omnibus Sworn Statement

Failure to comply any of the above conditions, The Bid Security shall be forfeited and appropriate sanctions and existing laws shall be imposed.

Finally, **Section 40.2** in the case of the failure, refusal or inability of the bidder with LCRB or HRRB to submit the documents required under Section 37.1 of this IRR or to enter into contract and post the required Performance Security, as provided in this Section, the BAC shall disqualify the said bidder, and shall initiate and complete the post-qualification process on the bidder with the second Lowest Calculated Bid/ Highest Rated Bid: this process shall be repeated until the LCRB or HRRB is determined for award. However, if no bidder passes post – qualification, the BAC shall declare the bidding failure and conduct a re – bidding with re – advertisement. Should there occur another failure of bidding after the conduct of the contract's re – bidding, the Procuring Entity concerned may enter into a negotiated procurement.
