**“A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 24-0686 TO STARGLASS TEMP & SIGNAGE PROFESSIONALS AS A SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE SUPPLY AND DELIVERY OF WARNING DEVICES/SIGNAGES UNDER BID NO. B-24-0007.”**

**WHEREAS**, the Provincial Government of Davao de Oro advertised the Invitation to Bid for the procurement of **SUPPLY AND DELIVERY OF WARNING DEVICES/SIGNAGES** under Bid No. **B-24-0007** POSTED on its website, the PHILGEPS, and at a conspicuous place within the premises of the Provincial Government of Davao de Oro continuously for seven (7) calendar days;

**WHEREAS**, the detailed evaluation of bids conducted on February 16, 2024, resulted in the following;


